

PHYSOR 2026 COPYRIGHT AND PUBLICATION AGREEMENT

By submitting the final version of the paper and selecting the approval checkbox on the submission platform, the Author(s) agree to the following terms.

1. Authorship and Warranties

The Author(s) declare that:

- the submitted contribution is original and does not infringe any third-party rights;
- they have the full authority to enter into this agreement;
- any third-party copyrighted material included in the paper has been properly authorized;
- all co-authors have agreed to the submission and to the present terms.

If the submitting author acts on behalf of co-authors, they confirm they are authorized to accept this agreement on their behalf.

2. Moral Rights

The Author(s) retain all moral rights related to the work, including:

- the right of authorship (paternity of the work);
- the right to the integrity of the work.

Moral rights remain exclusively with the Author(s) and are not transferred under this agreement.

3. Transfer of Economic Rights

provided that proper attribution is given to the original author(s) and to the first publication in the PHYSOR 2026 Proceedings.

This licensing model is consistent with European Union policies on Open Science and research dissemination.

5. Author Reuse Rights

The Author(s) retain the right to:

- archive the work in institutional or subject repositories;
- use the work for teaching and research purposes.
